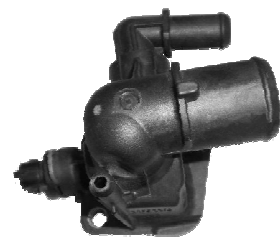

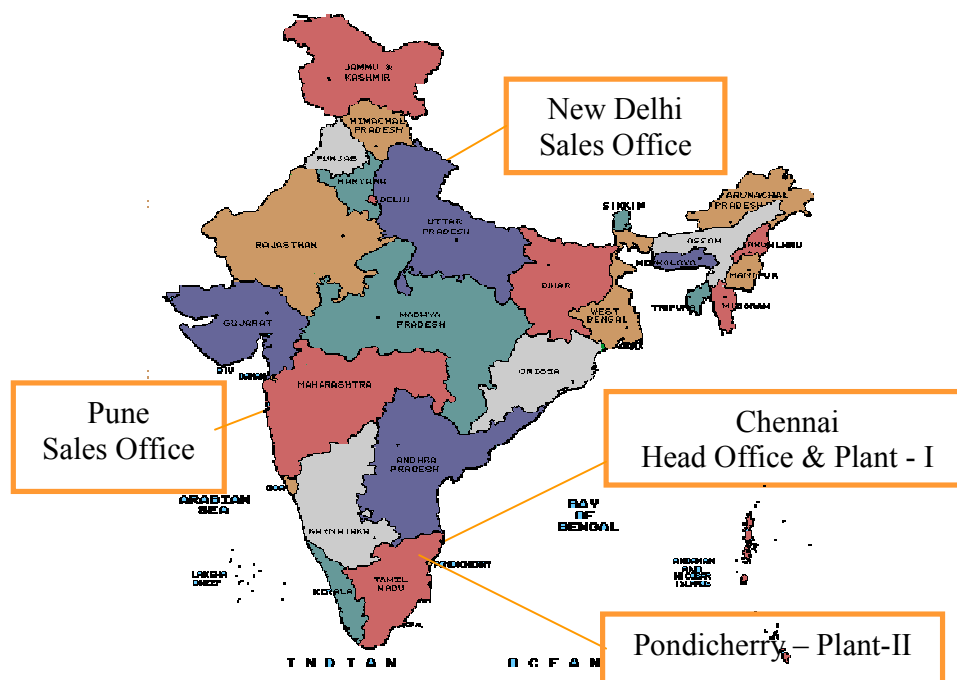

CTRI is a non-profit organization.



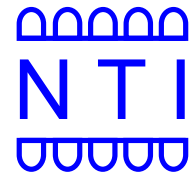
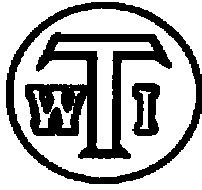
